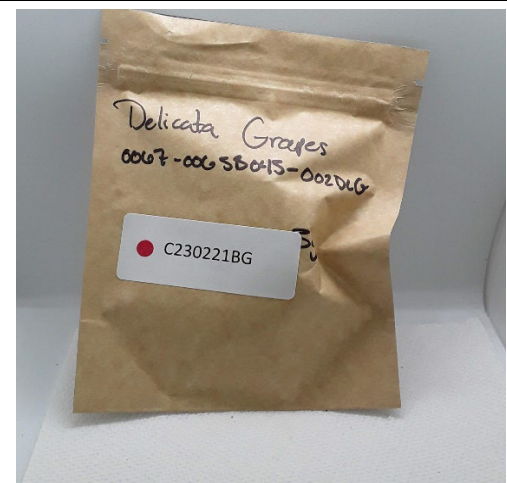
LOQ = The lowest quantity this method can reliably detect. Any terpene that was not detected is assumed to be less than the stated LOQ (<LOQ).
